Re: Productivity Commission Inquiry into Human Services

The purpose of this submission is to provide Community Employers WA's (CEWA) brief comments on the draft report released in June 2017.

CEWA is a registered Employer Organisation with the Industrial Relations Commission of Western Australia, and represents non-government, not-for-profit employers in the community services sector of Western Australia. CEWA has over 130 members comprising many of the largest and smaller Community Services Sector employers in WA, and continues to grow in numbers and influence. Our members employ in excess of 24,000 staff and are supported by over 10,000 volunteers. A list of our members is attached in Appendix 1.

Opening Comments:

We would like to thank the Commission for taking into account a number of our previous comments and including them in the draft report. We don't propose to comment on all aspects of the draft recommendations, however will focus on a few key areas of particular relevance to CEWA's objectives and the work of our employer members.

Draft Recommendation 7.2

We support the focus in the draft recommendations on achieving outcomes for service users, and incorporating these into the design on selection criteria. However, as previously highlighted in our earlier submissions, we remain keen to ensure that there is clearer acknowledgement of differentiating characteristics between NFP's and For Profits. Whilst we understand the Commission's desire to 'not discriminate', we are acutely conscious of the outcomes of similar reforms in other jurisdictions, where the NFP sector was effectively decimated. The UK is a well known example of this where changes to government policies in the 1990's resulted in major structural downsizing of the NFP sector and loss of service provision in many areas.

We concur that *'no organisational type has a monopoly on good, or bad service delivery'*, but see that as secondary to the primary motivation and driver of for profits being just that, to make a profit. This is a fundamental difference to the mission based NFP's who have a primarily civil society focused purpose and who effectively reinvest surpluses in the community.

Box 2.6 in the report does highlight the key differences in organisation types, however we question the comments that *'careful program design by stewards can harness these (motivations) in a manner that aligns providers and governments' objectives'*. The risk is that the design selection criteria and focus of the tender are highly unlikely to take into account the broader benefits to civil society of a strong and vibrant NFP sector. These go well beyond an individual contract, but once lost, will be very unlikely to be recreated. This is particularly relevant in regional areas where local involvement of the community and goodwill exhibited by many parties is even more important.

As such, we remain of the view that the differences between the NFP service providers and FP providers are of such a fundamental nature, that this needs to be more overtly acknowledged, as is the case in Western Australia under the Delivering Community Services in Partnership Policy. We would encourage the Commission to refer to that document and its focus on Community Outcomes and the valuable contribution of the NFP community sector.

Lastly, we concur with the recommendation for governments to *'allow sufficient time for providers to prepare considered responses'*, although note that this remains somewhat open to interpretation and thus at risk of being limited in its effectiveness.

Draft Recommendations 7.5 and 7.6

We welcome the recommendation of longer dated default contract lengths, and broadly support the rationale. We also support the recommendation to provide payments that reflect the efficient cost of service provision. Our concern however remains in the interpretation of this efficient cost, as is currently being worked through in the NDIS rollout.

One particular area of concern with longer dated contracts is the level of (or lack of) indexation. Historically that has been minimal across State and Federal governments and has been at zero in many instances. To have a funding commitment for seven years of fixed revenue, whilst paying wages and other expenses which rise annually, is unsustainable. In Western Australia, many NFP's are currently experiencing this with the Fair Work Commission's 2012, 9 year Equal Remuneration Order coupled with the annual wage cases, causing significant financial distress for many service providers. This year alone, those wage increases are in the order of 7% - against a flat revenue base. If this was to continue for 7 years, many organisations would not be solvent.

We would recommend that the comment in Draft Recommendation 7.6 be expanded to include a reference to appropriate indexation such that it reads *"That Australian. State and Territory Governments should provide payments to providers for family and community services that reflect the efficient cost of service provision, **inclusive of annual indexation.**"*

We thank you again for the opportunity to contribute and look forward to further dialogue when you visit Perth.
